Minutes of 2017 Annual Meeting

August 17, 2017 Brantwood Camp, Nelson, NH

Call to Order

Silver Lake Land Trust Chair Sal Mollica called the meeting to order at 10:10 am, expressing thanks for the good weather, and giving thanks to Ann and George Colony for providing the refreshments.

Secretary's Report

Secretary Doug Miller submitted the minutes for the 2016 Annual Meeting, which were included in the Annual Report distributed prior to the meeting. There were no additions or corrections to the minutes. It was moved by Jim Putnam and seconded by Ken Bacon that the minutes be accepted as submitted. The motion passed.

Sal apologized for not following up on the idea of purchasing blueberry bushes.

Treasurer's Report

Treasurer Bob Gogolen invited all to review the Treasurer's Report located on pages 10 and 11 in the Annual Report. There was a surplus income for the year totaled \$9,617.14. Net assets of the trust total \$221,967.29.

A motion was made and seconded to accept the Treasurer's Report as submitted. The motion passed.

Membership Report (Page 12 of Annual Report)

Linda Braun reported that the SLLT has 94 members, of which 5 were Conservators and 32 were Protectors. In 2016 there were 89 members; in 2015, 100 members; in 2014, 96 members.

A motion was made and seconded to accept the Membership Report as submitted. The motion passed.

Easements

Vice chair Eleanor Drury reported. There were no new conservation easements added in the last year, but with all of the conservation efforts done so far, there are 2.7 miles of shorefront and 75% of land area in the Silver Lake watershed conserved from development. In the coming year there is another opportunity to conserve 50 acres of land owned by Paul Geddes via the Seaver Silver Lake Farm Trust across Westside Road, to add to the 285 acres of land under

permanent conservation easement added by the trust from 2010-2015. We do not yet know the scope and timing of fundraising efforts for the Westside Easement, but it will be communicated ASAP. Adding these 50 acres will mean that 80% of the watershed is protected from development.

On behalf of the SLLT, Eleanor expressed thanks to Meade Cadot, Jeremy Wilson, Stephen Froling, and the entire staff of the Harris Center, as well as to Dick Ober, Ryan Owens, and the entire staff at the Monadnock Conservancy, for all of their help and effort to put this much land under permanent conservation.

Soak Up the Rain

Sal Mollica reported. There are 6 projects identified in total, with 1 complete. These projects will be completed by the end of the fall. Most of them are infiltration steps or water bars.

The Silver Lake Assn. and Silver Lake Land Trust are partnering to further mitigate erosion at the boat launch area, and this will incorporate two additional Soak Up the Rain projects, using up to \$2400 from the NH DES Soak grants. Plans include fencing to redirect traffic away from areas of erosion, terracing for land stability, infiltration steps to supplement the existing granite steps (without adding new steps down to the lake), and native hardy plantings.

Trustee Nominations/Elections

Laurie Appel offered thanks to all members of the Class of 2017. Josh Houle and Gretchen Lapham have agreed to be nominated to be members of the Class of 2020.

Laurie Appel moved that the following members be nominated to serve on the Board of Trustees as the Class of 2020: Class of 2017 members Eleanor Drury, Linda Braun, Ann Colony, Julia Pakradooni, Colin Kennard, Barbara Ross, Peter Allen, and Laurie Appel, as well as Josh Houle and Gretchen Lapham. The motion was seconded. There was no further discussion, and the motion passed.

Program

Sal Mollica introduced the guest speaker, Ryan Owens, Executive Director of The Monadnock Conservancy. Ryan discussed two topics, Greenways and Agricultural Conservation.

Greenways are aggregate conservation in contiguous blocks. These are important for many reasons, including wildlife migration and adaptation as conditions change, such as with climate change. One important factor in greenways is the diversity of landforms. Greenways come together from patience – some from conservation easements in contiguous blocks; some from conservation organizations owning land outright.

Agricultural conservation is important to maintain a long culture and tradition of farming. For a long time, agricultural conservation was primarily concerned with soil quality. Now the prevention of development is only a part of issue – the hard part are ways to increase access and affordability of farmland to farmers. Working with farmers has traditionally been hard and tended to be done at the "last minute". The new model is for land trusts to buy farmland, take the time to preserve it, and then find farmers to work the land as easements are placed. The

Monadnock Conservancy has not done this yet, but \$1.5 million has been raised so far in part with this idea in mind.

Renewable energy is now part of the challenge. Many old easements only two commercial activities – farming and forestry – but now are being written to allow something like the installation of solar arrays as well, and agritourism is becoming an interesting business. Future agricultural conservation easements will likely be less prescriptive.

The Monadnock Conservancy has recently invested a large sum to protect 367 acres on Chickering Farms, a dairy farm in the Connecticut River Valley. 70% of the farm's soil ranks among the most fertile in the area.

Adjournment

With no further business, Sal thanked all of those who attended. There was a motion to adjourn which was seconded and approved. The meeting was adjourned at 11:20 am.

Silver Lake Annual Report 2018

Land Conservation and The Westside Easement Campaign

For three decades, Land Trust members' support, and our Harris Center partnership, has steadily and consistently brought critical tracts of shoreline and steep slope acreage under easement to sustain the beauty of Silver Lake.

Thank you.

This year closes a chapter in the Land Trust's goal to protect and preserve great swathes of undeveloped land that were first conserved by Edgar Seaver and subsequently by Paul Geddes. We call this "The Westside Easement Campaign." It is through Paul's generosity that it is within reach. We are deeply grateful to him, John Newcombe his Trustee, and to Stephen Froling and the Harris Center, who steward the Seaver Silver Lake Farm Trust conservation easements.

As you'll recall, this chapter opened with Edgar's iconic Silver Lake Farm coming under easement, thanks to Paul. Next, a Nelson tract owned by Paul Geddes followed in 2010. Then, in 2015, *The Eastside Cricket Hill Easement's* sweeping steep slope acreage and shoreline added 194 acres through a successful fundraising campaign, on behalf of the Harris Center, supported by many Land Trust members and families and generous donors in the Region.

The Westside Easement will protect 50 undeveloped acres bordered by the Westside, Breed and Wells Lake Roads, and 792 feet of unbuilt shoreline. Once again preserving, undisturbed, the steep slopes and wooded ledge that defend against soil erosion, runoff, and water pollutants. Like the Seaver/Geddes' easements that came before, this helps promise, for generations to come, Silver Lake's treasured water quality and green shorescapes.

Fundraising since October 2017 goes well. We are encouraged and hope our September 30, 2018, goal will be met. But there is a gap. If you have yet to make a commitment, please send a check to the Harris Center, 83 Kings Highway, Hancock, NH 03449. Or, to donate using a credit card, or by transferring stock, call 603-525-3394.

The Westside Easement again will be the achievement of many gifts. Silver Lake Land Trust membership dollars help meet the goal. And to date, 70 individuals, families, and foundations, have made special pledges and donations to the Harris Center. Pledge payments are due December 31, 2018.

With success, we will open 2019 with 915 acres conserved within the Silver Lake Watershed. Of these, 335 were formerly Edgar Seaver and then Paul Geddes' land. In total, easements will protect 80% of our watershed and 2.9 miles of green shoreline – a source of pride and pleasure for us all. Again, thank you.

- 2. Boat Launch Rain Garden rehabilitation completed with DES and Monadnock Conservancy staff and volunteers
- 3. Ellis Infiltration Steps completed with Monadnock Conservancy staff and volunteers
- 4. Boat Launch Area Infiltration Steps largely completed with volunteers
- 5. Boat Launch Area Infiltration Bed and additional boulder placement completed using contractor
- 6. Four Additional Plans for private landowners prepared, but projects not completed
